 The plan is to approve the audit in June. In March, there will also be a discussion of
 succession planning. Three of the dates are dependent on outside presenters. The retreat will
 take place at a study session after the Community Needs Assessment has been completed.
 If there is no business, a meeting will be canceled with advance notice.

 See Admin Report for details on the accounting report. Month 13 is progressing and may be
 available sooner than in the past. The transfer amount to Reserves will be decided after receipt of
 the Month 13 report. Dates for the audit have been set. The audit report may be presented to the
 Board for approval in May. There was a surplus coming out of 2021.
- Library Director Director Perrault
 - o Monthly Administrative report Perrault highlighted the Spanish for Librarians classes as well as the *Theory of Enchantment* training.
 - o 4th Quarter 2021 Strategic Plan update

The 2021 circulation numbers were compared to 2020. The study session in April will look a little more closely at circulation numbers with the Annual Collections Report. Due to staffing issues and COVID limitations, some 4th quarter objectives were not accomplished. Following Board input, the 2022 Operating Plan was adjusted to show fewer measures. The 2022 Operating Plan will be discussed at the February Study Session.

At the last Colorado Association of Libraries conference, trustees heard about Grand County's Community Needs Assessment. The survey was done by an outside consulting firm and the results were more extensive than what the Library has done by itself. It was suggested that trustees review the financial policy as regards approval of larger expenditures and the RFP process.

<u>STAFF ACTION</u>: Before the February Study Session, Perrault will send trustees more information on the Community Needs Assessment and a link to the 2017 Library survey.

• Friends & Foundation - Ex. Director Walsh

Walsh shared some highlights of the Friends & Foundation fundraising plan, including the author event with Craig Johnson. Krueger invited the trustees to attend and bring 4 guests. Walsh invited the trustees to consider volunteering, as the F&F has a need for book store volunteers.

<u>STAFF ACTION</u>: Staff will forward the F&F fund-raising plan and budget documents to the trustees.

The Board congratulated the Friends & Foundation on another good year at Cliffhanger.
