• Gov't Affairs Committee – President Krueger

• Finance Committee – Hemphill

o FAMLI

Accountant Seckman explained the background of the Colorado Department of Labor's FAMLI program which resembles a short-term disability program with the addition of family care benefits. The Library District has the option to opt-in or out. Opting out requires Board approval by November. There was some discussion on the possibility of joining the short-term disability program currently under consideration by the Town as well as questions on the comparison of FAMLI to a short-term disability plan. The HR Team has been conducting a study on leave options which includes a review of short-term disability. The HR Team will present their report at the August Board Meeting.

• Library Report - Director Perrault

Perrault highlighted aspects of the Admin Report, especially the Friends & Foundation's support of the recent deposit on five workforce housing units for future staff use. She thanked the Friends & Foundation for their assistance.

   Walsh expressed appreciation to all who attended the Craig Johnson author event. Walsh will update the Board with attendance and donation numbers at the August Board meeting. Krueger thanked Walsh for her work on the event.
